Reply:

The government in late 2014 published online national and county maps that identify the homes, businesses and schools where commercial providers will deliver high-speed broadband access by the end of 2016. The government will invest in all the remaining areas to ensure that every home, school and business in Ireland has access to high-speed broadband, regardless of where it is located.

The maps, which allow the public to identify their own premises to see whether their high-speed broadband will be provided by a commercial operator or through State intervention, can be accessed at www.broadband.gov.ie The website also carries statistics on planned broadband coverage in County Louth. The Louth economic Forum has devised an overall 10 point plan identifying 10 specific areas to be addressed within its work programme and Broadband has been identified as one of the key factors in the plan. Following on from the publication of the county maps the broadband task group will now prepare the Louth Broadband Action Plan over the coming weeks and bring same to the Councils Economic & Enterprise SPC for noting

REPLY

New Speed Limit Guidelines are due to be published in the next few weeks. It is recommended that this motion be referred to Strategic Policy Committee for consideration in the context of the new guidelines.

The Chief Executive confirmed that new guidelines have now been published and these did not provide for a 20KPH speed limit but they did include a proposal for new rural road speed limit signage, and necessitate the review of all speed limits within two years of the publishing of the regulations.

Due to the success and commitment of Cork City Council and Waterford City and County Councils in developing the Tramore Valley and Kilbarry Bog landfills into public amenity that this Council commit to developing the former landfill site on the Newry Road, Dundalk in a similar fashion encompassing the following points;

As advised previously, the Waterford City Council site was redeveloped as a public park incorporating a 2.5km pedestrian path, trim trails, seating, signage and wildflower meadow areas at a cost of €1.2 million. The Cork City Council site was subject to a part 8 planning process in 2013 and its development is dependent on the availability of funding of €20million. Unfortunately, no such

funding is currently availability to develop the former landfill site on the Newry Road as a public amenity area..

That this Council develops a strategic policy and vision for the transformation of the former landfill site into public amenity and that this features in the forthcoming Local Area Plan for Dundalk.

The future use of the former landfill site will be determined in due course taking into account such factors as gas management, settlement and suitability of the site for future uses. It should be noted that the site is subject to an EPA licence and any development will be contingent on their approval.

That this Council reaffirm a commitment previously given at the now abolished Dundalk Town Council that once developed priority on the site should be given to playing pitches (1 for each code) and a public park in recognition of the historic absence of such social infrastructure on the Northern end of Dundalk.

While the question of considering the provision of playing pitches was discussed at previous Town Council meetings, no record can be found of a commitment to provide pitches as outlined, as the ongoing issue of settlement and gas management will determine the future use of the site. In addition, the current species of grasses growing on site were planted to encourage wildlife population and would not be suitable for playing pitches. The site would require leveling, application of a herbicide to eliminate perennial weeds, re-seeding with the proper species of grasses and maintenance.

That the Council liaises with relevant officials from Cork and Waterford local authorities and that appropriate presentations are invited in due course.

Council officials have already discussed the re-development of the respective landfill sites with their colleagues in both Cork and Waterford City Councils. A copy of the Cork City Council presentation is available on the City Council's website.

Recognising the Council's present financial position that EU and national grant aid is to be sought for the project.

As mentioned previously, the provision of funding is one of the challenges to the redevelopment of the former landfill site and this is not a priority under the 3 year Capital Programme. However, any suitable funding streams can be explored if the need arises.
