The Cathaoirleach Dolores Minogue welcomed Members back to the Special Council Meeting to consider the Chief Executive's Report on the submissions made on the Draft County Development Plan. The Cathaoirleach then requested the Meeting's Administrator go through the protocols for meetings and carry out a roll call.

Gráinne Tuomey, Meeting Administrator outlined the procedures for remote meeting participation, in line with the Council's adopted Standing Orders. On foot of a query raised at the last meeting regarding disclosures the following text was read to Members:

"When a matter comes before a meeting for consideration where an elected member or someone connected to the elected members have a beneficial interest, they are required to do the following:

Disclose the nature of his or her beneficial interest or the fact of a connected person's interest at the meeting and before discussion or consideration of the matter commences.

Withdraw from the meeting for so long as the matter is being discussed or considered and accordingly, he or she shall take no part in the discussion or consideration of the matter and shall refrain from voting in relation to it.

Where the elected member has actual knowledge that a matter is likely to arise at a meeting at which that member will not be present, and which, if he or she were present, he or she is required to make a disclosure in advance of such meeting and make such disclosure in writing and furnish it to the ethics registrar.

The Disclosure shall be recorded in the minutes and any subsequent withdrawal from the meeting and such disclosure shall be recorded in the register of interests."

A discussion took place around how to leave the meeting remotely and get back in again and it was agreed that members would leave the meeting, and rejoin immediately at which stage they would be put in the lobby, and the Meeting Administrator would allow them into the meeting from the lobby when discussion was over.

A roll call was held to determine who was present and the Cathaoirleach asked the CE to address the meeting. The CE advised members that she had discussed the meetings with the Senior Planner and the Director of Planning and the estimate was that the meetings were three meetings behind. A request was made to start meetings earlier at 4.30pm or have a meeting during the working day to catch up.

Many members objected to starting earlier stating they were not able to start earlier, and saying they would not attend a mid week meeting, some suggested meeting on Saturdays or Sundays or staying until 9pm.

The Chief Executive advised that she wasn't prepared to ask her staff to work on weekends or stay until 9pm as some of them lived an hour drive away and had young children.

Cllr. Pio Smith said the holding of meetings was up to the members to decide by resolution.

Cllr. Tomás Sharkey suggested that they would hold meetings without the CE present and it was their meeting, and wanted it minuted that the CE was not prepared to ask her staff to work weekends. Cllr. Tomás Sharkey made various comments about the rest of the staff and what they felt and wanted to know if it was the CE who was refusing to allow staff to work weekends or if other staff felt that way.

Joanna Kelly, Senior Planner advised Cllr. Tomás Sharkey in the interest of clarity that she was not prepared to attend weekend meetings or to ask staff to attend weekend meetings where there was no compromise from members and noted that all meetings held were outside working hours.

A lengthy heated discussion took place around what members wanted.

Cllr. Liam Reilly proposed that an extra meeting be added for two weeks and an early start of 4.30 for commencement be made on those two with a normal week in between. It was clarified that he proposed over the next three weeks meetings be held as follows:

Next week – an extra meeting be added and three meetings held from 4.30pm to 8.30pm

The following week – two meetings as already scheduled

The following week – three meetings from 4.30pm to 8.30pm

This was seconded by Cllr. Pio Smith.

It was proposed by Cllr. Antóin Watters that perhaps a day meeting could be held mid-week but that he would need two weeks’ notice to book annual leave. It was suggested that the Meeting Administrator would send around another doodle poll to find a day that might suit members. This was seconded by Cllr. Paula Butterly.
