The Cathaoirleach Dolores Minogue welcomed Members back to the Special Council Meeting to consider the Chief Executive's Report on the submissions made on the Draft County Development Plan. The Cathaoirleach then requested the Meeting's Administrator go through the protocols for meetings and carry out a roll call.

Gráinne Tuomey, Meeting Administrator outlined the procedures for remote meeting participation, in line with the Council's adopted Standing Orders, reminded members of their individual responsibility on Declarations and Ethics and took a roll call.

The Cathaoirleach called on Joanna Kelly Senior Planner to speak. Joanna Kelly referred members to the previous outstanding item on lands in Tullyallen.

**Review of Members Decision on CE Recommendation no. 271**

CE REPORT PAGE no. 407 – Submission DR575 - Diarmuid and Robert Byrne  
To Accept CE Recommendation:  
271 – No Change.

Members had voted not to accept the CE Recommendation at last meeting and had indicated a desire to zone an additional 10ha.

Cllr. Pio Smith said that he didn't accept the argument that a developer could come in develop the lands should the boundary be extended and get permission for c. 200 houses. Cllr. Pio Smith requested clarity on rezoning equivalent land mass should the area be zoned. He thought extension of zoning would give appropriate use of property and considered A1 appropriate, and sought further information on the protected road.

Joan Martin, Chief Executive clarified that her primary legal function is to give advice to members and that it is written in legislation that Members 'shall have regard to' her advice, and that she was satisfied that her advice is correct.

Joanna Kelly Senior Planner, advised Members that in making decisions on the Plan, Members have to have regard to the Core Strategy, which under S10 of the Planning & Development Act has to align with national and regional policy. She advised that the regional road was a protected route, and that these lands outside of the settlement were not serviced. Furthermore, the zoning of the lands would not provide for the permitting of new entrances onto the protected regional route. Where new residential lands were being developed there was a requirement to meet minimum density guidelines to ensure a sustainable use of lands.

Cllr. Pio Smith advised that he was not an expert and he was seeking clarity so he could understand. He did not believe that if land was zoned that a developer would come in to develop.

Following further discussion wherein the Senior Planner advised that Core Strategy S10 clarified that if you zone in one area you must remove elsewhere; Cllr. Pio Smith proposed that members voted again on the CE Recommendation of No Change. This was seconded by Cllr Michelle Hall.
