Various legal documents created as a result of unredeemed balances of a fee farm grant of April 1852 between Thomas Lord Baron Clermont and James Wolfe MacNeill relating to lands in north County Louth and County Armagh. Thomas Fortescue, First Baron Clermont of Dromiskin was born on 9 March 1815. He was the son of Chichester Fortescue and Martha Angel Hobson. He married Lady Louise Grace Butler in 1840. He held the office of High Sheriff of County Louth in 1839 and the office of Member of Parliament for County Louth between 1840 and 1841. He died on 29 July 1887 at age

72 without issue.

Baron Carlingford [Chichester Samuel Fortescue] was born at Glyde, County Louth, on 18 January 1823. In 1847 he was elected as a Liberal for County Louth; he retained the seat until he was defeated in 1874. He served as Chief Secretary for Ireland under Lord John Russell and William Gladstone. He was created Baron Carlingford in the resignation honours on 27 February 1874. In July 1887 he succeeded his brother Thomas as second Baron Clermont. ⁱⁱHe died on 28 January 1898. Baron Carlingford

was succeeded by the 4th Viscount de Vesci.

Archival History: These papers were deposited with Louth County Archives Service in

November 2004 by the County Louth Archaeological and Historical Society.

Scope and Content: This collection contains eight items relating to the fee farm rent of April 1852

made between Thomas Lord Baron Clermont and James Wolfe MacNeill

(head grant), a lease of June 1744 between Malcolm MacNeill and Daniel

McNeill and sub fee farm grants of September 1853 and November 1854.

The lands concerned relate to north Louth and county Armagh.

Memorandum of title made out for purposes of plaintiff's case where Henry A Johnston executor of James Moore deceased versus Lady Forster and others. It concerns a fee farm grant of 15th April 1852 (referred to as the head grant) between Thomas Lord Baron Clermont and James Wolfe McNeale (MacNeill), a lease of 28th June 1744 between Malcolm McNeale and Daniel McNeale and a sub fee farm grant of 29th September 1853 between Robert McNeale and James Moore. Queries relate to the lands of Lower Faughart, Ballynamenan (Whitemill), Monascribes, Culfore, Carrickaneena, Dromad, Navan, Ballymakellett, Drumnicarra, Lower Aughnaskea, Drumad, and Proleek.
