### **CONDITIONS FOR ERECTION OF POSTERS**

**Permission from Louth County Council for the erection of posters is given subject to the following conditions being met:**

1. Submission of Public Liability Insurance Policy to fully indemnify Louth County Council to the value of €6.5m.
2. Signs/Posters erected without permission will be subject to a litter fine.
3. Permission of owners of other property to be obtained in advance.
4. Posters to be erected 7 days prior to the event.
5. All signs/posters to be removed within **3 days** of the last performance/event (cable ties to be removed also).
6. Posters/Signs to be erected so as to not interfere with sight lines at junctions or the safe passage of pedestrians. They must not obscure motorists or pedestrian views of traffic lights, traffic management signs, directional signs or pose an obstruction.
7. Signs/Posters not to be erected on any council road signage or traffic light columns. Signs/Posters should be affixed to metal poles, and not be affixed to wooden poles. Signs/Posters not to be erected within 50 metres of any roundabout or junction.
8. Signs/Posters cannot be erected within the core area of any small town or village (i.e. within the 50kph signs).
9. Signs/Posters cannot be erected on any landscaped entrances to Towns/Villages.
10. No Signs/Posters to be erected on/around Market Square, Dundalk or on or in the vicinity of Ballmacscanlon roundabout.
11. Fee payable €300, with a refund of €250 upon removal of all posters within 3 days of event. Cheques to be made payable to Louth County Council.
