Amendment to Minute No. 35/26

Minute No. 35/26 was amended from: *"The expected timeframe for completion of the scheme is late 2027"* to: *"Works will commence on the realignment of the junction at R132/Marlbog Road/Seafield Road (Sexton's Junction) in late 2027. These works will be funded from Louth County Council's own resources. National Transport Authority (NTA) funding is not available for other elements of the Part 8 scheme."*

Matters Arising

Councillor Yore referenced Minute No. 32/26 and sought an update regarding parking issues at Dundalk Train Station. The Councillor advised that a generic response had been received from Irish Rail and queried whether Louth County Council had received a similar response. Director of Services, David Jones confirmed that he was not aware of any such response and undertook to verify the matter with Director of Services, Thomas McEvoy.

Housing Progress Report

Members noted the report, which had been circulated in advance of the meeting. Senior Executive Officer, Anthony O'Donoghue, responded to queries raised by Members. The following points were noted:

- A new Tenant Handbook is being launched for incoming tenants, accompanied by a keyring with a QR code providing online access.
- Concerns were raised regarding boiler servicing and the time elapsed since the most recent services. Mr. O'Donoghue requested additional information to facilitate follow-up.
- Vetting, including Garda checks, is carried out in respect of tenants. While allocations may be deferred based on the outcome of these checks, the Council has a statutory responsibility to provide housing.
- The need for additional electric vehicle charging infrastructure was acknowledged.
- Within County Louth Dundalk accounts for the highest number of applications on the housing list; however, forthcoming developments are expected to alleviate demand.

Roads & Local Services Report

Members noted the report, which had been circulated in advance of the meeting. Senior Executive Engineer, Patrick Callan responded to queries raised by Members. The following points were noted:

- Works to the Market Square fountain are nearing completion and are expected to conclude within the coming weeks.
- Clean-up works at Redeemer alleyway were completed; however, further dumping has occurred. The situation will be monitored with a view to implementing deterrent measures.
- The cleaning and disinfection of playgrounds will be followed up with the Parks Section.
- Request to close off the pitch at the Friary, when not in use, due to anti-social behaviour, was noted.
- The grass-cutting schedule to be requested from the Parks Section.
- "For Sale" signage at Elmore Lawns, is scheduled for removal.
- Further details were requested in relation to a business operating on Carlingford Pier.
- The derelict building in Omeath known as Dublin House, will be referred to the Dangerous Structures Team for assessment.
- A hotbox is being utilised to carry out pothole repairs in the locality.
- A meeting between Uisce Éireann and Louth County Council regarding the storm water network is pending confirmation.
- The potential for signage on Deerpark Road to alert road users and residents to the presence of horses in the area will be explored.

- Dundalk athletics track has been completed; however, an official opening date has yet to be confirmed.
- A programme of works is in place and will commence shortly to tidy up Dowdallshill graveyard ahead of the upcoming Blessing of the Graves.
- Locations of concern regarding speed ramps to be forwarded to Mr Callan for follow-up.
- Speed data from radar speed signs will be requested from the operator to assess its potential use in informing traffic calming measures.

Part 8 National Mobility Hubs Pilot

Senior Executive Engineer Noel Treanor, Senior Engineer John O'Hagan, Acting Senior Executive Planner, David Hall, along with a Senior Active Travel Consultant from Aecom Ireland Limited, Eilidh Russell presented the Chief Executive's Part 8 National Mobility Hubs Pilot. The following points were noted:

- Members have six weeks to either accept or reject the pilot.
- Locations may be removed at this stage; however, additional locations cannot be proposed.
- Phase 2 may include locations such as Dowdallshill Cemetery, IDA Business Park, Dundalk Retail Park, DKIT, Mount Avenue, and others.

Members discussed the report and voted on the proposal of Cllr. Yore, seconded by Cllr. Kelly for the removal of the following locations of mobility hubs:

Site ID 45 Cluan Enda- St Alphonsus Road
 Site ID 60 St Fursey's Terrace
 Site ID 65 Bellewsbridge Road/Fatima Park
 Site ID 68 Park View/Park Villas

For nearly 30 years, Ciara's family have been living with the devastation of her unexplained disappearance, while simultaneously having no official place of remembrance.

A memorial close to her home in Batchelors walk would provide somewhere for her family and the people of Dundalk to remember her, while also offering a place of solace for all who knew her.

Reply from David Jones, Major Capital Projects & Infrastructure Delivery

The Council fully acknowledges the sentiment of the Notice of Motion and notes that the matter of a memorial as requested can be considered in the context of the pending Memorial Policy which is to be brought forward by the Community & Placemaking Strategic Policy Committee as part of their 2026 Work Programme.

Discussion: Members generally supported the sentiment of the Motion with Cllr. Yore suggesting that the proposed memorial should be more collective rather than individual. While Cllr. Butler also raised the need for a memorial for women who have died violently. Cllr. Nash thanked Members for their support while noting the various views raised.
