That Louth County Council affirms its support for independent, trusted, and high quality local media and journalism, and will write to Coimisiún na Meán, the Taoiseach, and the Minister for Communications to

emphasise the importance of local radio and reporting in sustaining a strong shared identity and sense of belonging nationwide.

This council calls on the GAA to ensure all inter-county senior football and hurling games for 2027 are available for all to see on free to air TV and where required, on other online streaming platforms. Everyone should be able to watch their county team compete at inter county Championship matches.

19.0 Notice of Motion - Cllr. Fiona MhicConchoille

That this Council calls on the Government and the Minister for Social Protection to urgently establish a Waste Collection Allowance under the Household Benefits Package. That this Council recognises that refuse and recycling charges have increased significantly in recent years and now place a substantial financial burden on older persons, people living alone, carers, people with disabilities, and low-income households. Given that waste collection is an essential public health service, this Council believes that households already struggling with rising energy, food, and housing costs should receive direct support towards these charges, in the same way that assistance is currently provided for electricity and heating costs under existing social protection supports. That this Council further calls on the Government to work with local authorities and licensed waste operators to develop and implement a practical, fair and accessible scheme to assist eligible households with the cost of waste collection services. A copy of this motion shall be forwarded to the Minister for Social Protection, the Minister for the Environment, Climate and Communications, all local authorities, and the Oireachtas members for County Louth.

Go nglaoonn an chomhairle seo ar an rialtas agus ar an Aire Coimirce Sóisialaí chun liúntas bailiú dramhaíola a bhunú faoin phacáiste sochair teaghlaigh. Go dtugann an chomhairle seo faoi deara go bhfuil bailiú dramhaíola riachtanach mar sheirbhís sláinte poiblí, creideann an chomhairle seo go mba chóir do theaghlaigh a bhfuil ag streachailt le costais fuinnimh, bia agus costais tithíochta cheana (agus iadsan ag ardú), tacaíocht díreach a fháil sa mhodh céanna a bhfuil cabhair ann le haghaidh leictreachais agus costais teasa faoi thacaíochtaí coimirce sóisialaí. Go nglaoonn an chomhairle seo ar an rialtas chun oibriú le húdaráis áitiúla agus le hoibritheoirí dramhaíola ceadúnaithe chun scéim phraiticiúil agus chothrom a fhorbairt agus a chur i bhfeidhm do theaghlaigh incháilithe leis na costais do sheirbhísí bailiú dramhaíola. Beidh cóip den rún seo curtha ar aghaidh chuig an Aire Coimirce Sóisialaí, chuig an Aire Comhshaoil, Aeráide agus Cumarsáide, na húdaráis áitiúla go léir agus na baill Oireachtais anseo i gContae Lú.
